



BUSINESS CONTINUITY ADDENDUM TO IGEL END USER LICENSE AGREEMENT (EULA)

THIS ADDENDUM SETS FORTH THE TERMS AND CONDITIONS THAT ARE SPECIFIC TO THE BUSINESS CONTINUITY LICENSE VERSIONS OF THE IGEL SOFTWARE ("IGEL BC SOFTWARE"). THIS ADDENDUM IS IN ADDITION TO THE STANDARD TERMS IN THE APPLICABLE IGEL END USER LICENSE AGREEMENT ("EULA") BY AND BETWEEN IGEL AND END USER. IN THE EVENT OF ANY CONFLICT BETWEEN THE TERMS OF THE EULA AND THIS ADDENDUM, THE RELEVANT TERMS OF THIS ADDENDUM SHALL PREVAIL SOLELY AS TO END USER'S ACCESS AND USE OF IGEL BC SOFTWARE. PLEASE READ THIS ADDENDUM CAREFULLY BEFORE USING IGEL BC SOFTWARE. BY CLICKING "ACCEPT" (OR OTHERWISE ASSENTING TO THE TERMS OF THIS ADDENDUM) OR ACCESSING, INSTALLING, OR OTHERWISE USING THE IGEL BC SOFTWARE, YOU (A) ACCEPT THIS ADDENDUM AND AGREE THAT END USER IS BOUND BY ITS TERMS; AND (B) REPRESENT AND WARRANT THAT YOU HAVE THE RIGHT, POWER, AND AUTHORITY TO ENTER INTO THIS ADDENDUM ON BEHALF OF END USER AND BIND END USER TO ITS TERMS. IF END USER DOES NOT AGREE TO THE TERMS OF THIS ADDENDUM, IGEL DOES NOT LICENSE THE IGEL BC SOFTWARE TO END USER, AND END USER SHALL NOT ACCESS, INSTALL OR USE THE IGEL BC SOFTWARE, AND END USER SHALL PROMPTLY RETURN THE UNUSED IGEL BC SOFTWARE TO THE RESELLER FROM WHOM IT WAS OBTAINED.

1. **IGEL Business Continuity Software License.** Subject to and conditioned upon End User's compliance with the restrictions and other terms and conditions of the EULA and this Addendum and full payment of the applicable Subscription Key fees, IGEL hereby grants to End User a limited, non-exclusive, non-transferable and non-sublicensable license to use the IGEL BC Software for which End User has purchased a Subscription Key for End User's internal business purposes and solely in accordance with the Documentation. Use of the IGEL BC Software shall be strictly limited to the number and type of licenses as set forth on the applicable Order Form and for a maximum of forty-five (45) days per calendar year.
2. **IGEL Business Continuity USB Boot.** As an alternative to the software-only mode, the IGEL BC Software license also includes the right to receive and use a standard IGEL BC Software image installed on a dedicated IGEL USB drive distributed to End User that allows the End User to run the IGEL BC Software on a Device directly from the USB drive ("USB Boot"). Each IGEL BC Software License only permits a single Device to either use: (a) the software only mode of the IGEL BC Software (End User installs IGEL BC Software directly onto the Device) or (b) the USB Boot mode (IGEL preloads the IGEL BC Software on the USB drive and End User may boot IGEL BC Software onto the Device only using the USB drive). During the applicable term, IGEL will replace any defective USB Boot drives pursuant to the RMA (Return Material Authorization) request process, the details of which are available at <http://kb.igel.com/hardware/current/igel-business-continuity-usb-boot>.
